Definitions to WIOA Barriers are included below. North Dakota may have additional or modified definitions so please follow state definitions whenever provided if they differ from the examples below.

Included with this documentation is a Barriers questionnaire and staff form that you may give to students to help identify barriers, if desired. This form is not required at a state or federal level but is only to assist with programs who may wish to use it to assist in identifying hidden barriers to employment.

Barriers to Employment are Period of Participation based and should be updated (not over-written; the original entry should remain and additional updates should be added as new records) anytime the student has an exit of 90+ days without hours or scheduled services and then returns. Barriers to Employment can be updated or added to in the student record by going to the History tab>Barriers to Employment History panel and selecting +Add New Record.
